- State and Public accreditation
- Institutional and program accreditation
- · Compulsory and voluntary



The main reasons for establishing of institutional accreditation

- Traditional quality control of a HEI as a whole
- Impact of American institutional accreditation experience
- Number of units (HEIs) in one country
- Integrity of units (common resources, library, campus, budget etc.)
- Limited budgeting of the education system
- "Educational boom" in Russia (1995 2005)





Russian QA achievements

- Effective management of heterogeneous HE systems
- Inexpensive procedures
- Unified criteria for all HEIs
- Data base of all Russian HEIs
- Statistic analyses and criteria determination
- Information technologies for getting student outcomes and feedback in accreditation processes

- New state educational policy (support of public accreditation)









Mission of National Center of Public Accreditation







The main tasks of Public accreditation by NCPA

- Support to HEIs in establishing internal quality assurance systems in alignment with the European standards
- Identification and recognition of the best Russian HE programs meeting the European standards (*'elite club'*)
- Promotion (*advertising, lobbying*) of accredited programs within and beyond Russia (*Reference books, websites, exhibitions, etc.*)
- Implementation of the benchmarking methodology ("comparing one's own performance to best practices")

The main differences between State and Public Accreditation








Standards of Public Accreditation with compliance ESG-ENQA

- 1. Policy (mission, vision) and procedures for quality assurance of educational programs
- 2. Approval, monitoring and periodic review of educational programs
- 3. Assessment of student learning outcomes (competencies)
- 4. Quality assurance of teaching staff
- 5. Learning resources and student support
- 6. Information system providing effective implementation of the educational program
- 7. Public information
